Instructions for Completing the Washington County Environmental Charge (CEC) Municipality Remittance Report

Reporting Frequency: Municipalities who contract for solid waste collection on behalf of residents shall submit one (1) completed CEC report, along with any County Environmental Charge (CEC) remittance amount, per reporting period. Municipalities who contract for solid waste collection on behalf of residents shall submit one (1) completed report per quarter to the PHE Department.

Quarterly Reporting Schedule

January 1 – March 31	Quarter 1	April 20
April 1 – June 30	Quarter 2	July 20
July 1 –September 30	Quarter 3	October 20
