People with disabilities or older adults using Medical Assistance (MA)

Community First Services and Supports (CFSS)

Lub koom haum no muaj kev pab rau cov neeg muaj teeb meem pab tsis tau tus kheej, kev pab rau tus kheej kom nws nyob tau hauv nws lub vaj lub tsev, muaj neeg tuaj pab tus nws tus kheej, los yog daws kev nyuaj siab.

Case management and services for people with disabilities and older adults using Medical Assistance

Kev pab no txim muaj los pab tus kheej nyob yuj siab hauv nws lub vaj lub tsev los yog koom nrog zej zog, thiab pab kev noj qab haus huv, nyob tau kaj siab lug, nyob tau yam tsis ntsais dab tsis nrog zej zog.

- **Brain Injury (BI) Waiver**
Cov menyuaum yaus los yog cov neeg laus leejtwg muaj teeb meem paus hlwb ua yuav tau txais kev pab los ntawv nyob hauv tsev kho mob.
- **Community Alternative Care (CAC) Waiver**
Menyuaum yaus thiab cov laus leej twg pheej muaj mob tsis txawj zoo, los yog tsis tau li yuav tsum tau mus pw tsev kho mob.

- **Community Alternatives for Disability Inclusion (CADI) Waiver**
Cov menyuaum yaus thiab cov laus leej twg yuav tau txais kev pab xws li mus tsev laus.
- **Developmental Disabilities (DD) Waiver**
Cov menyuaum yaus los yog cov laus tsis taus tau txais kev pab los ntawm Rule 185 muaj neeg tuav tej taub nawv (vim yog nws laj lim tswv yim tsaug) yuav tsum muaj neeg los pab nws tag mus li nyob ib qhov chaws muaj neeg tu nws vim yog tus neeg ntawv tsis txwm peem ntawv nws tus kheej (ICF/DD).
- **Elderly Waiver (EW)**
Yog rau cov laus muaj 65 xyoo us nws xav nyob hauv nws lub vaj lub tsev los yog nyob koom nrog zej zog ua yuav tsum tau muaj neeg pab nws ib yam li nyob tsev laus.



Other services for people with disabilities and older adults

Alternative Care (AC)

- Rau cov laus 65 xyoo ua nws xav tau ib tug neeg pab nws tu nws tus kheej thiab pab ua nws tej hauj lwm nyiaj hnuv.

Ntawm no yog is qhov kev pab xws li yuav tsum tau muaj ib tug neeg tuav tej taub ntaw.

- **Essential Community Supports (ECS)**
Qhov kev pab no yog rau cov neeg laus muaj 65 xyoo ua nws tseem pab tau nws tus kheej. Yuav tsum muaj ib tug neeg tuav nws tej ntaub ntawv ib yam (case management).
- **Family Support Grant (FSG)**
Yog ib pob nyiaj muaj los pab rau cov neeg 25 xyoo ua muaj teeb meem ua rau nws pab tsis tau nws tus kheej thiab tseem nyob rau nws tsev neeg. *MnCHOICES not needed.*

- **Intellectual/Developmental Disabilities Case Management (IDD Services/Rule 185)**
Pab rau tus neeg laj lim tswv yim tsis txwm pua, tes taws tsis muaj zog.
- **Semi-Independent Living Services (SILS)**
Kev pab rau tus neeg nws xav nyob nws tus kheej yog rau cov laus ua laj lim tswv yim tsis txwm puas.
Yuav tsum tau txais IDD Services/Rule 85 Case Management.
